- A. **Call to Order.** The Final Millage and Budget Adoption Hearing was called to order by Mayor Andrews at 5:05 p.m.
- B. **Prayer and Pledge.** Prayer was given by Council Member Cain and Mayor Andrews led the pledge to the American Flag.
- C. **Agenda Items.**
  - 1. **Approval of Resolution No. 19-37** – Adopt the Final Millage Rate for Fiscal Year 2019-2020. Mr. Miner read Resolution No. 19-37 by title:

**RESOLUTION NO. 19-37**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF CHIPLEY OF WASHINGTON COUNTY, FLORIDA, ADOPTING THE FINAL MILLAGE RATE FOR FISCAL YEAR 2019-2020; PROVIDING FOR AN EFFECTIVE DATE.**

The following was also read:

The gross taxable value for operating purposes not exempt from taxation within Washington County has been certified by the County Property Appraiser to the City of Chipley as \$143,167,168.

The Fiscal Year 2019-2020 operating millage rate is 7.0000 mills which is more than the tolled-back rate of 6.9301 mills by 1.01%.

**A motion was made by Council Member Sasser and seconded by Council Member Cain to approve Resolution No. 19-37. The motion passed unanimously.**

- 2. Approval of Resolution No. 19-38** – Adopt the Final Budget for Fiscal Year 2019-2020. Mr. Miner read Resolution No. 19-38 by title:

The City of Chipley of Washington County, Florida set forth appropriations and revenue estimates for the budget for Fiscal Year 2019-2020 in the amount of \$10,227,136.
