- A. **Call to Order.** The Final Millage and Budget Adoption Hearing was called to order by Mayor Pro-Tem Russell at 5:05 p.m.
- B. **Prayer and Pledge.** Prayer was given by Mr. Sasser and Mayor Pro-Tem Russell led the pledge to the American Flag.
- C. **Approval of Agenda.**

A motion was made by Council Member Cain and seconded by Council Member Sasser to approve the agenda as presented. The motion passed unanimously.

D. Agenda Items.

- 1. **Approval of Resolution No. 22-32** – Adopt the Final Millage Rate for Fiscal Year 2022-2023. Mr. Miner read Resolution No. 22-32 by title:

RESOLUTION NO. 22-32

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF CHIPLEY OF WASHINGTON COUNTY, FLORIDA, ADOPTING THE FINAL MILLAGE RATE FOR FISCAL YEAR 2022-2023; PROVIDING FOR AN EFFECTIVE DATE.

The following was also read:

The gross taxable value for operating purposes not exempt from taxation within Washington County has been certified by the County Property Appraiser to the City of Chipley as \$170,703,632.

Now, therefore, be it resolved by the City Council of the City of Chipley of Washington County, Florida, that:

The Fiscal Year 2022-2023 operating millage rate is 7.0000 mills which is more than the rolled-back rate of 6.6344 mills by 5.51%.

This resolution shall take effect immediately upon its adoption.

A motion was made by Council Member Sasser and seconded by Council Member Cain to approve Resolution No. 22-32. The motion passed unanimously.

- 2. Approval of Resolution No. 22-33** – Adopt the Final Budget for Fiscal Year 2022-2023. Mr. Miner read Resolution No. 22-33 by title:

RESOLUTION NO. 22-33

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF CHIPLEY OF WASHINGTON COUNTY, FLORIDA, ADOPTING THE FINAL BUDGET FOR FISCAL YEAR 2022-2023; PROVIDING FOR AN EFFECTIVE DATE.

The following was also read:

The City of Chipley of Washington County, Florida set forth appropriations and revenue estimates for the budget for Fiscal Year 2022-2023 in the amount of \$17,233,393.

The City Council's intent to adopt a final millage and budget at a final public hearing and the required budget summary was properly published on September 28, 2022.

Now, therefore, be it resolved by the City of Chipley of Washington County, Florida, that:

The Fiscal Year 2022-2023 Final Budget be adopted.

This resolution shall take effect immediately upon its adoption.

A motion was made by Council Member Cain and seconded by Council Member Sasser to approve Resolution No. 22-33. The motion passed unanimously.
